ORDINANCE NO. 612

AN ORDINANCE ESTABLISHING THE TIME FOR THE APPOINTMENT OF CITY COMMITTEE MEMBERS, EMPLOYEES AND MEMBERS SO AS TO COMPLY WITH THE LEGISLATIVE CHANGE TO THE HOLDING OF CITY ELECTIONS AND AMENDING SECTION 206A OF ARTICLE 1 AND SECTIONS 1A03, 403 AND 503 OF ARTICLE 12 OF THE 2015 CODE OF THE CITY OF ST. FRANCIS, KANSAS AND AMENDING SECTION 2 OF ORDINANCE NO. 602.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Section 1-206A of the 2015 Code of the City of St. Francis, Kansas, be amended to read as follows:

- 1-206A **COUNCIL COMMITTEES; APPOINTMENT-** Standing committees of the governing body shall consist of three members each to be appointed by the mayor, by and with the consent of the council, at the first regular meeting of the governing body in January following the city election. The member first appointed shall be the chairman of the committee. Special committees of the governing body may be appointed from time to time by motion duly made and carried for the purpose. The following standing committees may be appointed:
 - (1) Utilities;
 - (2) Streets and Alleys;
 - (3) Parks (Sanitation-Refuse-Recreation)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Section 12-1A03 of the 2015 Code of the City of St. Francis, Kansas, be amended to read as follows:

12-1A03 **ROADSIDE PARK MEMBERSHIP-** The roadside park board shall consist of five members appointed by the mayor with the consent and approval of the council who shall serve on an annual basis from January to January. The board shall consist of one council person, a city employee, with the rest of the members being at-large from the community.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Section 12-403 of the 2015 Code of the City of St. Francis, Kansas, be amended to read as follows:

12-403 **POOL BOARD MEMBERSHIP-** The pool board shall consist of five members appointed by the mayor with the consent and approval of the council who shall serve on an annual basis from January to January. The board shall consist of one council person, the city superintendent, and three members at-large from the community. To the extent feasible, the at-large members shall be individuals who either utilize the pool or have family members who utilize the pool.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Section 12-503 of the 2015 Code of the City of St. Francis, Kansas, be amended to read as follows:

12-503 **THEATER BOARD MEMBERSHIP-** The theater board shall consist of five members appointed by the mayor with the consent and approval of the council who shall serve on an annual basis from January to January. The board shall consist of five members at-large from the community with one council member and the assistant city clerk or treasurer serving as advisors. To the extent

feasible, the at-large members shall be individuals who either utilize the theater or have family members who utilize the theater.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ST. FRANCIS, KANSAS, that Section 2 of Ordinance No. 602 of the 2015 City Code of the City of St. Francis, Kansas, be amended to read as follows:

SECTION 2. Composition. The PBC shall be composed of seven (7) members (the "Members") all appointed by the Governing Body. Three Members shall be members of the Governing Body and shall have a term of office that is co-terminus with their Governing Body term of office; two Members shall be members of the St. Francis Recreation Commission and shall have initial terms expiring on January 11, 2018; and two Members shall be at-large members of the community and have initial terms expiring on the first Monday of January, 2020. Terms of office for Members that are not the Governing Body Members, after the expiration of the initial terms, shall be for four (4) years. In the event that the PBC provides buildings or structures that are leased directly to governmental entities other than the City, (a) the composition of the PBC shall be modified by subsequent ordinance of the Council to conform to the requirements of the Act and (b) the Governing Body shall approve such buildings or structures.

These amendments to the 2015 Code of the City of St. Francis, Kansas shall be effective upon their publication in the St. Francis Herald.
