There is hereby terminated the Bird City-St. Francis-Cheyenne County Area Planning Commission which was created by the joint resolution and ordinances known as Cheyenne County, Kansas, Resolution 69-3, Bird City, Kansas, Ordinance No. 195, St. Francis, Kansas, Ordinance No. 327.


