# NCRPC HOUSING INITIATIVE: PILOT DEMOLITION PROGRAM

Administered by North Central Regional Planning Commission through a partnership with the Dane G. Hansen Foundation

### **About the Program**

Property owners in eligible counties may apply for a grant reimbursement to demolish a dilapidated residential structure (e.g. house, etc.) by completing the attached application and submitting the documentation listed below.

## Who is Eligible

2023 eligible service locations include the following Kansas counties: Cheyenne, Decatur, Gove, Graham, Republic, and Rooks

Assistance is available on a first come, first served basis. Funding is limited on a per county basis.

#### **How it Works**

- A maximum grant of \$5,000 per property is available. Please note that owners must provide proof of payment for
  the removal and cleanup of dilapidated properties for which they will be reimbursed for the exact cost up to, but
  not exceeding, \$5,000; or they can have the contractor invoice the North Central Regional Planning Commission
  (NCRPC) for the exact cost up to, but not exceeding, \$5,000 once the work is complete.
- Demolition project must be complete within 90 days after the application is approved by the NCRPC.
- Only one application per property owner.
- This is not an income-based program; anyone may qualify. However, if adjusted gross income for the household is greater than the maximums listed in the table below, a IRS 1099 Miscellaneous Income Form will be issued.

Verification of property ownership – Copy

Deed must be registered at the Register of Deeds Office in property owner(s) name.

Verification of most recent paid real estate taxes – Copy

Need receipt of 1st half or full payment of property taxes paid in December and/or May. This can be obtained from the County Treasurer's Office.

Copy of Form 1040, U.S. Individual Income Tax Return(s), for the 2022\* tax year (excluding schedules).

\*If taxes are in extension, then ineligible.

"Before" photo of project. Please note a final "after" picture of the project will be required for reimbursement.

#### Also needed:

**Within 10 days of submitting an application** and the supporting documentation listed in the checklist above, the Letter of Intent Certification (page 4) will need to be received to retain your reserved slot.
